A Confrontation of Ideologies

On the sixth day of the first session of the Lok Sabha, during the discussion on the vote of thanks for President Droupadi Murmu's address, PM Modi and opposition leader Rahul Gandhi came face to face. Central ministers Ashwini Vaishnaw, Kiren Rijiju, and spokesperson Sudhanshu Trivedi held a press conference, accusing Gandhi of insulting the entire Hindu community. Uttar Pradesh Chief Minister Yogi Adityanath said that Hinduism is the soul of India, representing tolerance, generosity, and gratitude, and demanded an apology from Gandhi for allegedly

wounding India's soul. Congress Defends Its

Congress General Secretary Privanka Gandhi defended her brother, stating that his comments were directed against the BJP, not Hindus. Reports also emerged of Sonia, Rahul, and Priyanka Gandhi meeting Lok Sabha Speaker Om Birla in his chamber. Political sources indicate that, following instructions from PM Modi, Union Home Minister Amit Shah, Parliamentary Affairs Minister, and other senior BJP leaders are engaged in extensive consultations on the events that

unfolded in Parliament. Looking Ahead

It remains to be seen how PM Modi will respond to Rahul Gandhi's remarks during his reply to the discussion on the President's address on the final day of the Parliament session on Tuesday. The political drama in the Lok Sabha underscores the intensifying battle between the ruling party and the opposition, with Rahul Gandhi stepping into his new role with a combative and assertive approach.

Udaipur Faces Potential Dog-Free Future

Udaipur: Concerns have arisen following a recent news report suggesting that Udaipur may soon become devoid of street dogs. The report mentions that 4,500 dogs in Udaipur have already been sterilized, with 13 dogs undergoing the procedure daily. The current pace of the campaign has raised fears that Udaipur could eventually be left without any street dogs.

The author also highlights past changes in the city, such as the closure of Udaipur's stepwells in the 1970s and their subsequent preservation efforts. Similarly, the use of fluoride toothpaste was promoted, only for it to later be advised against due to the risk of fluorosis. The shift from iodized salt to advocating for locally ground and Lahori salt is another example. Additionally, foreign tree species like Conocarpus and Eucalyptus were planted under government schemes, which are now found to be

harmful to the environment and public health. The author expresses curiosity about the criteria for selecting the 13 dogs sterilized daily in Udaipur and is concerned that future campaigns might be needed to conserve dog species. The author stresses that any campaign should be based not
