#### Clarity and Transparency: The Key to Implementing **New Criminal Laws**

The introduction of three new criminal laws — the Bharatiya Nyaya Sanhita, Bharatiya Nagarik Suraksha Sanhita, and Bharatiya Sakshya Adhiniyam — has ignited a fierce debate between the ruling BJP and the main Opposition party, the Congress. While the BJP touts these laws as symbols of India's progress and resilience, the Congress criticizes the government's methods, accusing it of forcibly passing the laws in Parliament following the suspension of 146 MPs. The Congress, along with the INDIA bloc, has vowed to resist what they term 'bulldozer justice' within the parlia-

The government insists that the new statutes prioritize justice and rights protection, contrasting sharply with the

punitive focus of the colonial-era laws they replace. Despite these assurances, the Opposition and several legal experts remain skeptical, raising concerns about potential misuse of the laws.

One significant concern is the anticipated surge in litigation, with appeals for re-evaluating cases registered before July 1, 2024, and reviews of the new legal framework. The chaotic rollout, while expected, places the government under pressure to consider suggestions from various stakeholders and potentially amend the laws for better clarity and functionality. Calls to scrap the statutes altogether are also expected to grow louder.

Reforming the British-era Indian Penal Code, Code of Criminal Procedure, and Indian Evidence Act is a commendable goal, but the task of achieving consensus and effective implementation is daunting. For the BJP-led government, which no longer enjoys the overwhelming dominance it once did, rallying broad support will be challenging. Law enforcement agencies, judicial officers, and legal professionals face a formidable task in adapting to the new laws, and litigants will encounter new complications.

In this transitional phase, clarity and transparency are paramount to mitigate uncertainty and confusion. The government must work diligently to avoid a repeat of the fiasco surrounding the three farm laws, which were ultimately repealed after prolonged protests by farmers. Only through open dialogue, careful consideration of feedback, and transparent implementation can the new criminal laws fulfill their intended purpose without plunging the legal system into

## **Developed Rajasthan 2047: Zero Loss Mining** and Future Prospects

Udaipur: In a significant move towards modernizing the mining sector, Udaipur's Director of Mines, Mr. Bhagwati Prasad Kalal, has called for the adoption of the latest global technologies to achieve zero loss mining. Speaking at a meeting held at the Mineral Building in Goverdhan Vilas, Mr. Kalal emphasized the necessity of private participation in mineral exploration to accelerate the process and reduce reliance on mineral imports. He highlighted the sector's critical role in providing employment and generating revenue.

Mr. Kalal's address was part of the vision document for "Developed Rajasthan/2047," envisioned by Chief Minister Mr. Bhajanlal Sharma. The state, currently mining 57 out of its available minerals, has

abundant resources that present vast opportunities for exploration, mining, industry, employment, and revenue generation. Projections suggest a threefold increase in mining lease areas, employment, and government revenue by 2047.

During the meeting, several

key suggestions were made to

enhance the mining sector's efficiency and output. These included granting industrial status to mining, exempting stamp duty calculations on mining lease contracts from DLC, and extending the mining lease period from 50 to 90 years. Clarifying premium calculations for mining leases up to 2040 and allowing installment payments for premiums were also proposed. Additionally, there were calls to adjust fixed rent calculations for lease transfers and provide



barren government land for afforestation to meet CTO conditions. Declaring mining areas and restricting residential and other industrial developments nearby, ensuring access roads to auctioned plots on government land, and mandating the use of M-sand in government projects were other notable recommendations. The formation

of a district-level committee to handle EC provisions, removing the need for a no-objection certificate from the Forest Department for diverted mining leases, and implementing royalty categories based on feldspar quality were also discussed. Streamlining the process of obtaining clearances through a "single win-

dow" system, including representatives from the mining area in the DMFT Council, granting preferential rights to previous leaseholders in nonmajor mineral auctions, reducing GST rates for the mining sector, auctioning all minerals with blocks, making no-dues certificates available online, simplifying the mineral inclusion process, and streamlining the gap allocation process rounded out the comprehensive set of suggestions.

Additional Director of Mines, Mr. Deepak Tanwar, provided a detailed overview of the state's mining scenario and stated that the Rajasthan/2047 vision document would give new direction to the mining sector in the state. Mining Engineer Mr. Asif Ansari and representatives from various mining associations also participated, offering their suggestions.

The Director assured that all suggestions would be forwarded to the government for consideration. This initiative is part of the broader Vikasit Bharat Abhiyan initiated by Prime Minister Narendra Modi, aligning with Chief Minister Bhaianlal Sharma's directives for the Vision 2047 document.

The emphasis on clarity and transparency in implementing these new measures is crucial to avoiding the pitfalls experienced during the farm laws' rollout.

By addressing stakeholder concerns and incorporating their feedback, the government aims to steer the mining sector towards sustainable and inclusive growth, contributing significantly to the vision of Developed Rajasthan/2047.
