

Visionary MLSU Board Meeting Led by Prof. Sunita Mishra

Udaipur: A transformative meeting of the Mohanlal Sukhadia University (MLSU) Board of Management was held under the chairmanship of Vice-Chancellor Prof. Sunita Mishra on Tuesday. The meeting focused on progressive reforms in academic recruitment, administrative infrastructure, and operational policies



Discussions included the long-pending Career Advancement Scheme (CAS) for faculty promotions. However, sealed envelopes containing promotion details could not be opened, as Financial Controller Seema Yadav emphasized the need for thor-

ough document verification per government guidelines. Amonthlong deadline was set to complete the process, with a followup meeting scheduled.Approval was granted for the recruitment of 88 new academic positions, contingent on financial clearance from the government. Furthermore, employees under the Self-Finance Board will now be appointed and compensated under the RTPP Act, effective January.

The board also sanctioned the construction of a state-ofthe-art administrative complex, including a multi-purpose examination hall and new buildings for the Food & Nutrition Department, Law College, and Engineering College.

While significant strides were made in academic and administrative domains, concerns arose as student-centric issues remained unaddressed. Participants, including lawmakers and senior faculty, expressed optimism for these forward-looking initiatives to shape MLSU's future.

The meeting underscored the university's commitment to excellence and growth while highlighting the need for a balanced focus on student welfare.
